### **Credentialing & Privileging Project**

The provincial privileging standards project will identify objective, criteria-based privileges and associated standards for physicians, dentists, midwives, nurse practitioners and other health professionals as identified by the Physician Quality Assurance Steering Committee (PQASC) practicing medicine in British Columbia. These privilege dictionaries will bring consistency in understanding and expectations across the province for those requesting privileges, as well as those approving privilege requests, with the ultimate goal of ensuring patients are being properly diagnosed and treated by practitioners who have met the predetermined standards.

Nurse Practitioners from Health Authorities, Universities and the CRNBC are participating in this project. ### **B.C.'s Nurse-Family Partnership Program**

Once a baby is born in B.C., all sorts of services kick in to support mom and baby, the health authorities and ministry are interested in reaching all women during the earlier parts of their pregnancy. Aside from Northern Health, which has had a pre-natal registry for 12 years, most of the Health Authorities have only just launched their pre-natal registry (and all have different names). The Ministry and Health Authorities want to get the word out to nurse practitioners, physicians and midwives about this important service, and are asking NPs to help raise interest and knowledge in the registry. ### **Rural Health Consultation**

The Ministry of Health has asked BCNPA to participate in a discussion on rural health, along with counterparts from some of the other professional associations and the health authority CNOs. The purpose of the day will be to facilitate discussion on: whether the work being undertaken supports the objectives/meets population needs, to consider what policy considerations are required to support this work, and to determine what actions are required to address barriers and concerns. Stay tuned for future updates on the outcomes and recommendations of this forum.

### **Regulation/Legislation Update**

As you know there were regulatory/legislative changes made in Bill 17 on May 29, 2014, however the implementation of the changes is not complete for all the acts.

Further work is required by government to the following acts:

SECTION 136: (Employment and Assistance for Persons with Disabilities Act, section 2)

SECTION 138: (School Act, section 92)

SECTION 144: (Workers Compensation Act, section 1) – changes to occur January 2014
